SPECIAL ORDINANCE NO. 769

AN ORDINANCE AUTHORIZING THE DECLARATION OF AN EMERGENCY BY THE MAYOR DUE TO THE CORONAVIRUS AND AUTHORIZING TEMPORARY PROTOCOLS AND PRACTICES FOR THE CITY DURING THE STATE OF EMERGENCY.

WHEREAS, the Governor of the State of Missouri has declared a state of emergency on March 13, 2020 in response to the coronavirus and;

WHEREAS, the President of the United States has also declared a state of emergency in response to the coronavirus and;

WHEREAS, the Board of Aldermen of the City of Cuba, Missouri (City), has determined that it is in the best interests of the City to enact rules and regulations to prevent the spread of the coronavirus in accordance with the recommendations of the CDC.

BE IT ORDAINED, by the Board of Aldermen of the City of Cuba, Missouri, as follows:

Section 1: The City of Cuba, Missouri, shall declare a state of emergency for the next sixty days, or until further action from the board whichever occurs first, and limit the access of the public to city council meetings to video observation only.


Section 2: The City shall waive late fees, the 3% fee for credit card usage and require everyone utilize the drop boxes, online pay, and mail to avoid foot traffic to city hall.

Section 3: Allow new connections for public utilities to call in to set up services and pay in the same manner as existing customers.

Section 4: The City shall allow a 15% abatement for electric payments on all Cuba utility bills, not to include businesses with a current abatement.

Section 5: This ordinance shall be in full force and effect from and after its passage and approval.
