AN ORDINANCE AMENDING CHAPTER 24 ARTICLE V SECTION 14.1 (G) OF THE CUBA CITY CODE ADDING NEW BUSINESSES AND REMOVING BUSINESSES TO THE PRETREATMENT PERMIT LIST

WHEREAS, it is in the best interests of the health, safety, and welfare of the citizens of the City of Cuba Chapter 24 Article V Section 14.1(G) of the Code of the City of Cuba be amended as set out herein; and

WHEREAS, There have been changes in ownership and businesses that have moved into and out of the City of Cuba, Missouri; and

WHEREAS, it is in the best interests of the health, safety, and welfare of the citizens of the City of Cuba that the pretreatment ordinance in Chapter 24 Article V be amended as set out herein; and

Now, therefore, be it ordained, by the Board of Aldermen of the City of Cuba, Missouri, as follows:

Section One: Amendment: CHAPTER 24 Article V Section 14.1(G) is hereby amended to read as follows:

G. The following SIU's are those that are to be regulated as of the date of the issuance of the pretreatment permits or earlier as determine by the Pretreatment Coordinator. The Permits Fees are annual and are payable on or before July 1 of each calendar year.
