ORDINANCE NO. _____

AN ORDINANCE INCREASING WATER FEES FOR WATER AND SANITARY SERVICES PROVIDED BY THE CITY OF CUBA, MISSOURI.

Recitals:

A. WHEREAS, it has been determined by the Board of Aldermen of the City of Cuba, Missouri an increase in water fees is necessary to maintain funding of the sanitary sewer and water service, which was in existence on November 1, 2002.

Now therefore, be it ordained, by the Board of Aldermen of the City of Cuba, Missouri, as follows:

Section 1: Increase in Water Rates. The water rates for such services provided by the City of Cuba, Missouri, shall be changed in accordance with the schedule which charges will be based on a monthly billing cycle:

Water rates:

Residential

First 2,000 Gallons	\$18.00 minimum charge
Next 4,000 Gallons	\$5.00 per 1,000 gallons
Next 40,000 Gallons	\$4.00 per 1,000 gallons
All Excess Gallons	\$3.00 per 1,000 gallons

Industrial

First 2,000 Gallons	\$18.00 minimum charge
Next 4,000 Gallons	\$5.00 per 1,000 gallons
Next 40,000 Gallons	\$4.00 per 1,000 gallons
Next 100,000 Gallons	\$3.00 per 1,000 gallons
Next 150,000 Gallons	\$2.50 per 1,000 gallons
All Excess Gallons	\$1.80 per 1,000 gallons

Section 2: Maintenance and Statement of Costs. The City clerk shall keep at her office available for public inspection a statement of the costs necessary to maintain the funding of the water and sanitary sewer services of the city which statement and work papers related thereto shall be a public record and subject to examination pursuant to Chapter 610, Revised Statutes of Missouri.

Section 3: This Ordinance shall become effective with the first day of the billing cycle beginning November 1, 2021.
