AN ORDINANCE AMENDING CHAPTER 5 ARTICLE 1 SECTION 5-5, OF THE CUBA, MISSOURI, CITY CODE, MODIFYING THE FEE FOR ADOPTING AN ANIMAL FROM THE CUBA ANIMAL SHELTER

Be it ordained, by the Board of Aldermen of the City of Cuba, Missouri, as follows:

Section 1: Amend Chapter 5, Article 1, Section 5-5 of the Cuba City Code to read as follows:

SECTION 5-5 Redemption and fees

The owner of an animal shall be entitled to resume possession of any impounded animal before it is disposed of, upon compliance with the license provisions of the City's ordinances and the payment of the impoundment fees. The animal control officer shall require that such animal be vaccinated with an anti-rabies vaccine as a condition of the release of such animal. Said vaccination shall be given by a licensed veterinarian and proof of said vaccination shall be provided to the animal control officer. Any animal impounded under the provisions of this article may be reclaimed by the owner only upon payment to the City of \$25.00 for the first impoundment within the preceding one year period, \$50.00 for the second occurrence within such one year period and \$75.00 for the third occurrence within such one year period, plus \$5.00 for each day or a fraction thereof such animal is impounded by the City. Animals unclaimed within the holding period described above may be given away to any interested person other than the owner upon payment of an adoption fee of \$60.00. Additional fees may be required to cover the costs for veterinarian services, and such other person's commitment that the animal is not being taken for return to the original owner thereof. If the animal is less than is under 4 months old, adopter will be responsible for rabies vaccination at the time of spay/neuter surgery.

Section 2: This Ordinance shall be effective from and after its date of passage.
