AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF CUBA, MISSOURI, ON BEHALF OF SAID CITY, TO ENTER INTO AN AGREEMENT WITH VAUGHAN POOL & SPAS FOR THE REPLACEMENT OF POOL GRATES

WHEREAS, the Board of Aldermen of the City of Cuba, Missouri (City), has determined that it is in the best interests of the City to enter into an agreement with Vaughan Pools & Spas for the replacement of pool grates.

BE IT ORDAINED, by the Board of Aldermen of the City of Cuba, Missouri, as follows:

Section 1: The City of Cuba, Missouri, shall enter into an agreement with Vaughan Pools & Spas for the replacement of pool grates.

A copy of said Agreement is attached hereto as Exhibit "A".

Section 2: The Mayor of the City of Cuba, Missouri, is authorized to execute the Agreement on behalf of the City.

Section 3: All ordinances or parts of ordinances therefore enacted which are in conflict herewith are hereby repealed.

IF SUIT IS FILED AGAINST OWNER TO COLLECT ANY SUM DUE UNDER THIS AGREEMENT, OWNER AGREES TO PAY COURT COST AND A REASONABLE ATTORNEY FEE IN ADDITION TO ALL OTHER SUMS DUE.
