AN ORDINANCE AMENDING SECTION XII OVERTIME IN THE HANDBOOK FOR CITY OF CUBA, MISSOURI EMPLOYEE HANDBOOK RELATING TO OVERTIME FOR THE POLICE DEPARTMENT FOR THE CITY OF CUBA, MISSOURI

WHEREAS, the Board of Aldermen of the City of Cuba, Missouri (City), has determined that it is in the best interests of the City to amend the rate of pay for police officers when working under grants.

NOW, THEREFORE, BE IT RESOLVED, AS FOLLOWS:

Section 1 - The City of Cuba, Missouri, hereby approves and modifies section XII Overtime to read as follows:

Occasionally unpredictable or unavoidable situations will require overtime work; we try to limit overtime but when it is necessary, the employee supervisor will give individuals as much advance notice as possible. Employees pay rate for scheduled and approved overtime work will be at one and one-half (1 1/2) time the regular hourly rate or comp-time given at one and one-half (1 1/2) times the amount of time spent for all work in excess of forty (40) hours per work week. council meeting OJ/05/01 Note: Forty hours worked includes vacation and holiday time used, but not comp, personal, and/or sick time. In consideration for fuel, driving time, etc., there shall be a minimum of one (1) hour overtime credit given per call. This policy shall be in accordance with FLSA regulations.

All Police Employees pay rate for scheduled and approved overtime work will be at one and one half (1 1/2) time the regular hourly rate or comp-time given at one and one-half (1 1/2) times the amount of time spend for all work in excess of 86 hours worked in a 17-day period. Note: 86 hours worked includes vacation time used, but not comp, personal, and/or sick time. This policy shall be in accordance with FLSA regulations. Changed occurred when pay frequency changed January 2017.

On occasion, the City of Cuba, Missouri enters into agreements for law enforcement grants for overtime with the Missouri Highways and Traffic and Safety Division. If the terms of such grant authorize up to two times the rate of pay for overtime worked pursuant to a grant, then the police officers shall receive two times their regular hourly rate if the grant fully covers that time worked.

All comp-time shall be scheduled and taken at the supervisor's discretion.

Section 2 - This ordinance shall be in full force and effect as of the date of its passage by the Board of Aldermen of the City of Cuba, Missouri.
