AN ORDINANCE ESTABLISHING CHAPTER 18 ARTICLE V SECTION 18-44, OF THE CUBA, MISSOURI, CITY CODE, IN ACCORDANCE WITH MISSOURI STATE LAW AND ESTABLISHING A PROHIBITION ON THE POSSESSION OF TOBACCO BY MINORS

WHEREAS, It is having been established by the State of Missouri that it shall be unlawful for any person under the age of 21 to purchase, attempt to purchase or be in possession of tobacco.

THEREFOR, be it ordained, by the Board of Aldermen of the City of Cuba, Missouri, as follows:

Section 1: Chapter 18, Article V, Section 18-44 of the Cuba City Code shall read as follows:

SECTION 18-44 MINORS IN POSSESSION OF TOBACCO

No person under the age of twenty-one (21) may possess cigarettes, or any products with tobacco or alternative nicotine products, or vapor products.

(1) Persons under the age of 21 possessing any of these items shall be deemed to have committed an ordinance violation and subject to a penalty not to exceed \$100.00 or 10 hours of community service for a first violation, for a second violation not more that \$250.00 or twenty-five (25) hours of community service and for a third or subsequent violation not more than a fine of \$500.00 or fifty (50) hours of community service.

(2) A minor in possession of any such products shall have such products confiscated immediately.

Section 2: This ordinance shall be in full force and effect as of the date of its passage by the Board of Aldermen of the City of Cuba, Missouri.
