SPECIAL ORDINANCE NO. _____

AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF CUBA, MISSOURI, ON BEHALF OF SAID CITY, TO EXECUTE A QUIT CLAIM DEED TRANSFERRING REAL PROPERTY TO THE CUBA FIRE PROTECTION DISTRICT.

WHEREAS, the Board of Aldermen of the City of Cuba, Missouri (City), has determined that it is in the best interests of the City to transfer real property to the Cuba Fire Protection District.

BE IT ORDAINED, by the Board of Aldermen of the City of Cuba, Missouri, as follows:

Section 1: The City of Cuba, Missouri, shall transfer real property owned by the City to the Cuba Fire Protection District. A copy of said deed is attached hereto as Exhibit A.

Section 2: The Mayor is hereby authorized to execute the deed on behalf of the City.

Section 3: This ordinance shall be in full force and effect from and after its passage and approval.

Quitclaim Deed

KNOW ALL MEN BY THESE PRESENTS, that the **City of Cuba**, Missouri, a municipal corporation of the fourth class organized and existing under the laws of the State of Missouri, with its principal office in Cuba, Missouri, as Grantor, in consideration of TEN AND NO/100 DOLLARS (\$10.00) and other valuable consideration, to it paid by **Cuba Community Fire Protection District**, a political subdivision organized and existing under the laws of the State of Missouri, with its principal office in Cuba, Missouri, as Grantee, receipt of which is hereby acknowledged, and by virtue and in pursuance of the authority of the Board of Aldermen of the City of Cuba, Missouri, does by these presents REMISE, RELEASE and FOREVER QUIT-CLAIM, unto said Grantees, and their heirs, personal representatives, successors and assigns, the real estate situate in the County of Crawford in the State of Missouri, more particularly described on the attached Exhibit "A".

Including all appurtenant easements inuring to the benefit of the above land as the dominant tenement and subject to all easements to which the above land is the servient tenement. Subject to all dedications, covenants, reservations and restrictions on use of record.

TO HAVE AND TO HOLD THE SAME, with all the rights, immunities, privileges and appurtenances, thereto belonging, unto the said Grantees and unto their heirs, personal representatives, successors and assigns forever; so that neither the said Grantor, nor any other person or persons, for it or in its name or behalf, shall or will hereafter claim or demand any right or title to the aforesaid premises or any part thereof, but they and each of them shall, by these presents, be excluded and forever barred.

Real estate situated in the Crawford County, Missouri, more particularly described as follows:

Part of the SE ¼ of the SE ¼ of Section 24, T39N-R5W AND part of the S ½ of lot 3 of the SW ¼ of Section 19, T39N-R4W of the 5th P.M. in Crawford County, Missouri, more fully described as follows:

Commencing at the SW Corner of Section 19, T39N-R4W; thence along the Section line N 1°14'18" E, a distance of 424.90 feet to the POINT OF BEGINNING; thence leaving said Section line N 88°19'01" W, a distance of 21.36 feet; thence N 1°17'27" E, a distance of 448.37 feet; thence N 89°17'33" E, a distance of 278.43 feet to the West line of a 60 foot wide ingress and egress Roadway and Utility easement as described in Deed #201900190 of the Crawford County Recorder's Office; thence along said right-of-way line S 1°16'21" E, a distance of 134.29 feet and S 1°28'17" E, a distance of 326.35 feet; thence leaving said right-of-way line N 88°19'01" W, a distance of 278.64 feet to the POINT OF BEGINNING; said described tract containing 3.01 acres.
